A. Selelekela

Kopo eo e ikamahantse le Khaolo ea 24 (3) ea Molao oa LEA oa 2002, o hlomathisitsoeng.

B. Kopo le Mabaka ao WASCO e a behileng Kopong ea eona

Ka la 16 'Mesa 2019, WASCO e ile ea etsa Kopo ea hore litheko tsa litšebeletso tsa metsi, likhoerekhoere le litefiso tsa khoeli le khoeli (Standing Charges) li nyolloe ka linoko tse robeli feeloane hlano lekholong (8.5%) bakeng sa mekhahlelo eohle ea basebelisi ba metsi. WASCO e boetse e kopile hore ho kenyeletsoe M10.00 litifisong tsa khoeli le khoeli (Standing Charges) mokhahlelong oa Band A. Ka kakaretso WASCO e kopile chelete e M279.04 millione eo ho eona; M246.25 millione e tla sebelisoa phanong ea litšebeletso tsa metsi ha M32.79 millione e tla sebelisoa phanong ea litšebeletso tsa likhoerekhoere.
